

ELIZABETH CITY HISTORIC PRESERVATION COMMISSION

The Historic Preservation Commission is organized pursuant to NCGS 160A-400.7 and the City's Unified Development Ordinance Section 3-7. The Commission seeks to promote, enhance and preserve the character of the City's historic districts. Chief among its duties is to consider applications for Certificates of Appropriateness in accordance with Section 12-8 of the UDO. The Commission generally meets on the second Thursday of each month at 4:30 p.m. in Council Chambers. Membership consists of seven members serving staggered, three year terms. Normal tenure is two consecutive terms, but additional terms may be authorized by the City Council. A majority of the members shall be an owner, have a leasehold interest or reside in the historic districts and have a demonstrated special interest, experience or education in history, architecture, archaeology or related fields. Appointments shall reflect a mix of downtown and residential interests. If a member loses his/her designated status, their term shall be automatically terminated.
