Re: Consideration - Consent for Surplus Property Disposal

BACKGROUND:

The City Manager (or his/her designee) is authorized to declare surplus any City personal property valued at less than five thousand dollars (\$5,000) for any one item or group of items, to set its fair market value, and to convey title to the property for the City in accordance with the procedures established in this resolution.

ANALYSIS:

Public Utilities currently has surplus beyond useful life to the City. This includes the tentative surplus and liquidation of a 2013 Freightliner Recycling Truck valued at \$55,000 via the City's virtual auction clearinghouse GovDeals.
