The Board makes recommendations to the City Council and the County Commission regarding all matters relating to parks and recreation services. The Board meets on the second Thursday of each month at 5:30 p.m. at Knobbs Creek Recreation Center. Membership consists of one County Commissioner, one City Councilor, two County citizens, two City citizens and one member appointed jointly by City and County. Terms are for two years, with a six year limit.
