

STORMWATER ADVISORY BOARD

Established by Council motion on November 14, 2011. Amendment to Stormwater Management Utility Ordinance of August 25, 2014 established membership makeup and terms, as follows: "There shall be a Stormwater Advisory Board appointed by the Elizabeth City Council. The membership shall consist of seven (7) members; three (3) City Council members; and four (4) City residents, with one representative from each of the City's four Wards." Ordinance established expiration of then current members' terms:

1. Three (3) City Council members ending in December 2015 with their City Council term;
2. Ward One Representative ending August 1, 2015;
3. Ward Two Representative ending August 1, 2015;
4. Ward Three Representative ending August 1, 2016;
5. Ward Four Representative ending August 1, 2016.

After initial appointments, terms are two years, staggered.

The Board is charged with the responsibility to monitor completion of Stormwater Utility action items, report on progress to completion, liaise with the County Stormwater Board, oversee the education and outreach efforts and make recommendations to Council on further action.
