

ELIZABETH CITY URBAN FORESTRY COMMISSION

The Urban Forestry Commission was established by ordinance in November 2008 (Chapter 59-2). The Commission's duties, among other things, includes developing and maintaining the City's Urban Forestry Management Plan for inventory, development, conservation and care of the urban forest resources of the City and to coordinate and/or conduct special projects for the betterment of the urban forest. Seven members appointed by the Mayor with the approval of the City Council. All members shall reside in Pasquotank County with no more than two members living outside the corporate City limits. Members serve staggered three-year terms. City Manager may appoint non-voting, ex-officio members. *Members may not serve more than three successive terms.*
